The Board of Mayor and Alderman met on October 30, 2023 to review and finalize the items on the agenda for the November 6, 2023 meeting.

Planning and Zoning- The date for the next Planning and Zoning Commission meeting is November 6, 2023. There will be a Question-and-Answer session regarding the subdivision regulations.

Finance- There was nothing to report.

Law and Order- There was six (6) citation issued last month. Violations included speeding and running stop signs.

Historical- The historic meeting scheduled for November 7, 2023 has been cancelled, as there are no items on the agenda.

Streets- How to resolve the flooding issues in town is still being looked into. Mayor Pucciarelli plans to contact Congressman Burchett to see how he could help.

Parks and Recreation – There was nothing to report.

Tourism- The DCOM Fall Fest had some traffic issues that should be addressed before next year's event.

Water – Mayor Pucciarelli congratulated the board for completing the required utility training.

Last year the state required the town to test the water quality every quarter. In the fourth quarter the test was done at the end of the quarter instead of the beginning, which resulted in a violation during the recent state inspection. The violation only pertained to the timing of the test, not the water quality.

Sewer- There was nothing to report.

Fire Department- Cumberland Gap is hosting the next county fire chiefs meeting on November 9th which will be held at the fire station.

OSHA- There was nothing to report.

Litigation- There was nothing to report.

Old Business:

Guardians of the Gap- TN Downtown Grant Update- Colloredo & Associates, along with members of the grant steering committee, is currently working on a new and more efficient design for the town website.

Special Event Permit Application- MedWar 2023
